



**TRIANGLE CRICKET LEAGUE  
ASSUMPTION OF RISK, WAIVER AND RELEASE AGREEMENT**

Assumption of Risk: I understand that the Triangle Cricket League (the “League”) was formed for the purpose of providing an opportunity for youth and adults, including adult employees of companies located in the Research Triangle Park, to participate in recreational cricket. I understand and accept that I may be exposed to certain hazards and risks of personal injury or property damage by participating in the League activities and transportation to and from these activities. I choose to participate in the League in spite of these risks and hereby assume all risks of injury or loss of life to myself, and loss of or damage to property arising out of my participation in said League. I understand the inherent risks involved in participating in said League and accept the full responsibility for any and all such damage or injury which may result. I have been advised that no insurance coverage is provided by the League or through the League registration fee.

Waiver and Release: In consideration of the individuals and entities who administer the League allowing me to participate, and in consideration of the entities who own or lease the fields on which League games are played allowing me to utilize the fields on their property, and in consideration of the granting of permission to use the fields by the Durham-Wake Counties Research and Production Service District, who has constructed and maintained the fields, I specifically release and forever discharge all of the individuals and entities referenced on Exhibit A attached hereto, and their officers, agents and employees, from any and all liability or claims for any injury, illness, death, or loss of or damage to property which I may suffer while participating in the League. This release and discharge specifically includes, but is not limited to, liability or claims for injury, illness, death or damage caused by the negligence of any of the individuals or entities referenced on Exhibit A, or their officers, agents or employees. It is my intent by execution of this Waiver and Release to release the individuals and entities named on Exhibit A and to hold them harmless from all liability from any such property loss or damage, personal injury or loss of life, whether caused by their negligence or whether based upon any breach of contract, breach of warranty, or any other legal theory. I also agree that participant's likeness may be photographed or videotaped and that such image may be published in an outlet used to promote or publicize the league’s programs.

In signing this document, I fully recognize that if injury, illness, death or damage occurs to me while I am engaged in participation of games or practices, or any other event in connection with the League, I will have no right to make a claim or file a lawsuit against the entities or individuals referenced on Exhibit A attached hereto, or their officers, agents or employees, even if they or any of them negligently cause my injury, illness, death or damage.

I have carefully read this Agreement and understand its contents. I am aware this is an assumption of risk, waiver and release of liability, and I sign it voluntarily. I also understand that I should not and may not participate in this activity if I am under the influence of alcohol or drugs.
